Definitions

- **Websites:** All Balwurk websites under the master domains: balwurk.com
- **Cookies:** Small data files stored on your hard drive or in device memory.
- **Web beacons:** Electronic images that may be used in our websites to help us deliver cookies, count visits, understand usage, and campaign effectiveness.

Why do we use cookies or similar technologies?

To provide a personalised service to our users, it is necessary to memorise and store information about how you use our websites via cookies. These files contain reduced amounts of information downloaded to the computer or other device.

On each subsequent visit, your internet browser sends these cookies back to our website to enable recognition and memorisation of your user preferences.

How do we use cookies?

Like most online services, our websites use first-party and third-party cookies for several purposes. The first-party cookies are primarily necessary for the websites to function the right way, and they do not collect any of your personally identifiable data.

The third-party cookies used on our websites are used mainly for understanding how the website performs, how you interact with our website, keeping our services secure, providing advertisements that are relevant to you, and providing you with a better and improved user experience and help speed up your future interactions with our website.

How can you control the cookie's preferences?

You can manage your cookies preferences by clicking on the "Settings" button and enabling or disabling the cookies categories on the popup according to your preferences.

If you change your preferences later through your browsing session, you can click on the "Cookies Policy" tab on your screen. This will display the consent notice again, enabling you to change your preferences or withdraw your consent entirely.

In addition, different browsers provide different methods to block and delete cookies. You can change your browser's settings to block/delete the cookies.

What type of cookies can you find on our websites?

We use different types of cookies, which enable three types of functionalities with different degrees of optimisation of the browsing experience and service levels:

- **Session cookies:** these are temporary cookies that remain stored in the browser until the user leaves the webpage, so no record is left on the user's hard drive. The information gathered by these cookies are used to analyse site traffic patterns, which enables us to improve the content and navigability of the site
- **Permanent cookies:** these cookies are stored in your browser and used when you return to our website

What cookies do we use on our websites?

The cookies used on our website are grouped into the following categories.

Necessary

Necessary cookies are essential for the website to function correctly. These cookies ensure basic functionalities and security features of the website anonymously.

Functional

These cookies help to improve the functionality of our website, allowing us to remember user preferences and choices on our websites.

Analytics

These cookies enable us to carry out statistical analysis of how users use the websites. We examine the navigation on our website with the aim of improving the services we make available to you.
